New Business:

- I. Staff Report (30 minutes):
 - A. Staff Plan in First Quarter 2022
 - 1. Listening & Research Mode
 - 2. NFC Staff Notes (NHC Meeting Notes, 1st Quarter Plan, Action Items)
 - a) Strange because there are some details that we are unsure of, but still trying to gather information and pull together information based on general info available
 - b) Jan Strategic planning to develop an internal plan for the staff
 - (1) Should be hearing back from the County in early January

- c) Feb Listening Sessions
 - (1) Plan to have some greater clarity around how we will be able to operate and move forward
- B. Location
 - 1. NHC Plan = Wait & See
 - a) Staff is willing to listen and hear any directives from the BOD of what they would like for us to do
 - b) Once we gain more info and clarity from the County, we will be able to develop a timeline
 - (1) Needing to hire a General Manager
 - c) We have been talking with experts and collaborators in the Cooperative field
 - 2. Coca-Cola Building
 - a) Got a call from the agent, Terry Espy, and communicated our situation with the county. Detailing that our priority is to follow through with the possible relationship with the County first
 - b) They are now in a position to look into what a grocery store could look like in this building
- C. Funding
 - 1. City ARP Funds \rightarrow \$185,000
 - a) This is taking a lot of time to transfer the funds to our account. We do have the final contract in the inbox, just waiting on our insurance agent to write and submit the \$25,000 bond to the City
 - b) Expect the \$25,000 to be in our account this week and then reimbursements after that
 - c) We have been granted \$25,000 upfront
 - d) Funds need to be spent within a year
 - 2. Novant Funds \rightarrow \$200, 000
 - 3. LOI feedback on HFFI Grant
 - 4. County \rightarrow Might be willing to give \$400,000?
 - 5. Not sure if we still need to go to the bank to fill in the gaps in funding needed
- **D.** Non-Profit Update \rightarrow Allows us to engage culturally and meet the needs of the community through community engagement
 - 1. Weekly Wednesday working meeting
 - a) Collaboration with NFC BOD
 - 2. Need (2) committed BOD Members to file with IRS
 - a) Don't need to push this through with placeholder people...we really need to think about who would be a great fit for these BOD positions
 - b) Meet with current BOD to help with alignment
 - 3. Can we apply for grants through a fiscal sponsorship with VOYAGE
 - 4. BOD made a decision to put the nonprofit work on HOLD
- E. Frankie's Outdoor Market
 - 1. Anne York started a text chain and it did prove to be successful to bring new faces to the market
 - 2. With the weather, the attendance has decreased but we want to stay consistent
 - a) Looking into the price of outdoor heaters
 - b) Promoting free hot beverages on our social media accounts
 - 3. Marketing new video out there and we plan to do more such as a Farmers Market-specific newsletter
 - 4. Lunch N' Learn new educational programming for the market. The first one will be January 22nd, 2022, and will be led by Oriana Bolden at Freedom Dreams Farm


- 5. Looking into a curbside option.

- F. Ownership Report
 - 1. Are we going to keep a Co-op model?
 - a) Voice & Vote \rightarrow would this still be present for the members if the business model changed
 - 2. Do we want to put membership/ownership sales on hold
 - a) Need to get rid of the term owner \rightarrow use membership
 - (1) Need to change this language on all of our platforms
 - 3. There would be no option to refund but communicating how we are changing and how their membership can be used in the grocery business in this new term
 - 4. Passive in selling memberships until the end of January
